**Membership Terms and Conditions:** By signing this application I understand and agree that (a) membership in the Milwaukee Teachers' Education Association ("MTEA") and its affiliates is for an entire membership year from September 1 thru August 31, and renews automatically each year; and (b) my ability to enjoy the rights, privileges, and benefits of my membership is conditional on my timely payment of dues. My paying membership makes MTEA possible and entitles me to participate in union decisions and activities, and in all the rights and privileges guaranteed by the union constitution.

**Payment Authorization:** I hereby agree to pay the annual dues and PAC contributions established by MTEA and its affiliates in consideration for the services the union provides. I understand that these amounts are approved annually by MTEA and its various affiliates' Representative Assemblies and may change from year to year. If I change job class or status during the year, I will remain a member of MTEA and, beginning with the first pay period after the change, I will be charged at the rate applicable to my new member type and status, as described above. I authorize on a continuing basis, and regardless of my membership status, the payment of those annual amounts established by MTEA and its affiliates as described herein unless I revoke this authorization in a signed writing to MTEA at 5130 W. Vliet St., Milwaukee, WI 53208 prior to the start of any membership year (or, in the event that I change job class or status, before my next pay check after the change is issued); in doing so, I will also forfeit my membership in MTEA and its affiliates.

**Telephone Consumer Protection Act Consent:** By providing my phone number, I understand that the National Education Association ("NEA") and its affiliates including the Wisconsin Education Association Council ("WEAC"), MTEA, NEA Member Benefits, and NEA360 may use automated calling techniques and/or text message me on a periodic basis. The NEA, WEAC, and MTEA will never charge for text message alerts, although carrier message and data rates may apply. I can email membership@weac.org to stop receiving or for more information.

**Political Action Committees ("PACs"):** The NEA Fund for Children and Public Education ("NEA FCPE"), the WEAC Political Action Committee ("WEAC PAC") and the Milwaukee Teachers' Education Association Political Action Committee ("MTEA PAC") are political action committees funded solely by voluntary member contributions—not dues—including small amounts, published annually, that by default are included with dues in the member payments described above. Both NEA FCPE and WEAC PAC use contributions primarily for making contributions to and expenditures on behalf of candidates for federal and state office, while MTEA PAC uses contributions primarily for making contributions to and expenditures on behalf of candidates for state and local office. Only U.S. citizens or lawful permanent residents may contribute to these funds. Contributions to these funds are voluntary; making a contribution is not a condition of membership in the NEA or any of its affiliates, and members have the right to refuse to contribute without suffering any reprisal. I may contribute more or less than the suggested amount, or nothing at all, without it affecting my membership status, rights, or benefits. The NEA FCPE, WEAC PAC and MTEA PAC are subject to regulation by the Federal Election Commission and the Wisconsin Ethics Commission. Federal law requires the NEA FCPE to use their best efforts to collect and report the name, mailing address, occupation, and name of employer for each individual whose contributions aggregate in excess of \$200 in a calendar year. State law requires PACs to use their best efforts to collect and report the name and mailing address of all PAC contributors, as well as the occupation of those who contribute in excess of \$200 in a calendar year.

**Political Action Rebate:** I may request a refund of that portion of my payment designated for WEAC/NEA political activity by writing to WEAC, PO Box 8003, Madison, WI 53708 between Sept. 1 and Oct. 30, or within 60 days of joining. Once I request a WEAC PAC rebate, no WEAC PAC payments will be drawn in future membership years unless I specifically request in writing to reinstate WEAC PAC participation. I may annually request a refund for that portion of my payment designated for MTEA political activity by sending a signed, written request to MTEA, 5130 W Vliet St, Milwaukee, WI 53208, each year before Oct. 1. My memberships will not be affected by a request for refund.

**EFT Dues and PAC Withdrawal Authorization:** To facilitate my payment of annual dues and additional PAC contributions described on this form, I hereby authorize MTEA or WEAC—which ever organization the Executive Board of MTEA, at its sole discretion, determines can do so most efficiently—to initiate Electronic Funds Transfers (EFTs) from the bank account described below. The annual dues and associated PAC contribution amounts for the current membership year and each year thereafter, which may vary as described above, shall be withdrawn starting on the first full payday in September. The amount of my bimonthly payment is my annual dues obligation plus associated PAC contributions divided by 20 pay periods (Sept. - June), unless MTEA has selected a different payment schedule. My authorization is in full force and effective until I terminate it by notifying MTEA in writing at 5130 W. Vliet St., Milwaukee, WI 53208, or until termination of my eligibility to maintain membership in MTEA. I understand my written notification to MTEA must be made by the 1st day of the month in order for this agreement to be terminated or changed in any manner for the following month.

Dues payments are not tax deductible as charitable contributions for federal income tax purposes. However, they may be tax deductible as ordinary and necessary business expenses. Contributions to PACs are not tax deductible. I am attaching a VOIDED CHECK for verification of bank information.
