Delegate allocations will be calculated based on local membership as of March 1, 2022. On March 2, an email will be sent to local presidents (those locals that have both a president and secretary identified in IMS) containing information on the number of delegates for their local and instructions on how to complete the delegate registration form **electronically**. These delegate registration forms will need to be completed by **April 20**. Any exceptions due past the deadline date of April 20 will need to go through the WEAC Executive Director's office for approval. Please share this out within your Regions so delegates are aware of this change. WEAC will mail packets to all registered delegates containing the proposed budget and campaign literature on behalf of candidates. Other materials will be posted on the WEAC RA website.

Elections: WEAC RA delegates will elect candidates to the offices of WEAC President, Vice-President, Secretary-Treasurer, NEA Director and NEA Alternate Director, as well as the Minority Guarantee Representative and Alternate to the WEAC Board of Directors.
