B. Health Insurance

- a. Last BAC meeting was on 1/26/23.

- c. Consideration of two different options: Option 1(d) and Option 6, in terms of projected savings.
 - i. Option 1 (d) (Going from \$500 deductible to \$1500 deductible option): possible savings of \$1,968,688.
 - ii. Option 6 with Buy-up Contribution: possible savings of \$1,947,477.
- d. Premiums take into consideration of the new 7.16% rate increase, and their rates according to staff status (Employee only, Employee/Spouse, Employee/Child, and Family)
- e. GBAPS' decision is that there is a moral choice/ethical perspective regarding making premium payments that they are not using.
- f. GBEA is trying to having the increased costs as minimal as possible.
- g. Savings aren't as big as initially believed, in spite of the \$26M-\$36M deficit for the district.
- h. There were questions asked by the Executive Board and the BAC regarding the insurance options, rates, and savings.
- i. There will be a meeting on 2/1/23, with BAC, and then on 2/13/23 at the School Board meeting.

- j. Need to explain the & 7.16% rate and how it affects our insurance options and savings at this time. Discussion was had on whether the GBEA will represent our involvement as a collaborative endeavor.
- k. Communication will be sent to members regarding health insurance information in the local area.
