B. Executive Director's Report

a. Handbook Committee

- i. The committee met with the GBAPS leadership and the process was constructive in having a voice.
- ii. Biggest hurdle has been unpaid leave and the number of days members use, especially for non-medical unpaid leave.
- iii. We've gone over budget on substitute teacher coverage by over \$2 million.
- iv. It was initially 3 days every 5 years, with no extension of breaks. GBEA would like to have 3 days of unpaid leave every 3 years, whether we have a break or not.
- v. There was discussion on PTO (Paid Time Off) as well and its accrual and effects on retirement, as well as calendars that align/rotate with neighboring school districts have been rather difficult.
- vi. GBEA's position is to keep IPP on the table and in our handbook.
- vii. Congratulations to all winners of the Spring 2023 elections!!!

b. District Budget and Facilities

- i. The deficit is between \$15 million and \$25 million. GBAPS is playing out different scenarios, with regards to funding at the state level. Accounts for \$350 per pupil, 4% or 8% (current CPI max) cost increase, without steps.
- ii. If the state reimbursed public schools for special education, we would have and extra 16.6 million dollars. Multilingual education would have over 8 million dollars. \$7.5 million for cost of living increased.
- iii. GBAPS is limited to a pupil funding cap of \$10,000 and Kenosha has a pupil funding cap of \$10,599 that date back to 1993. If GBAPS had the additional \$599 per pupil funding, we'd receive an additional \$7-8 million.
- iv. Facilities Task Force will meet on 4/18/23. Presentation will be held on 5/8/23, with table top meetings on 5/9/23 at West HS, and 5/10/23 at East HS. Recommendations are made by the GBAPS School Board.

- v. School boundaries ought to change every 3-5 years, as opposed to the 30+ years it has been since the boundaries were drawn.
- vi. Advocacy is important and we need staff to please communicate with members and the community about these issues.

c. Staffing

- i. There is no process at this time regarding all of the logistics, as there are too many variables in place over several years.
- ii. The GBAPS leadership will work with all bargaining units to commit to work together.
- iii. School Board elections matters and support GBAPS School Board members, especially those supported by the GBEA.
- iv. There are no layoffs this year. There is no reduction-in-force language at this time.
- v. Regarding displacements, placement will need to happen prior to position being open to the public. Involuntary transfers occur in August or September as positions may occur in the event a coverage is needed at another building, although they have a position available at previous school, if there is an opening in which one is certified.
